News from Alcester Police

Counterfeit Money - Please be aware there has been a rise in the circulation of counterfeit notes across the county. If you would like a counterfeit detector pen please contact:- Alex Williams Business Crime Advisor, Community Safety and Substance Misuse, Community Services, Communities Group, Warwickshire County Council on 02476483163/ 07920814897 or email www.warwickshirebusinesswatch.co.uk . We understand that there has been a number of notes passed in Alcester and we advise retailers and business owners to report incidents of notes being passed on 101 straight away.

Please be aware of one of the latest scam alert from Warwickshire Trading Standards: Retired homeowners are warned to beware of unexpected phone calls from sales people who are using scare tactics and claiming that the Government can take their home. These callers may attempt to give the impression that they are legally trained solicitors and that their services are free of charge. In reality however, they are sales people attempting to get homeowners to pay out potentially thousands of pounds to create trusts and similar legal devices with a view to protect a home or assets from being sold to pay for care fees. Anyone receiving such a call should note: If you require legal advice, ensure you speak to an expert, for example a solicitor. Councils may view attempts to avoid residential care home fees in this way as deliberate deprivation of assets. Never buy goods or services from cold callers.

Using mobile phones when driving - New Law - It's illegal to use a hand-held phone or similar device while driving, or riding a motorcycle. The rules are the same if you're stopped at traffic lights or queuing in traffic. It's also illegal to use a hand-held phone or similar device when supervising a learner driver or rider. You must stay in full control of your vehicle at all times. The police can stop you if they think you're not in control because you're distracted. This includes if you're using devices like your sat nav or car radio. When you can use a phone in your vehicle. If you're the driver, you can only use your phone in a vehicle if you: need to call 999 or 112 in an emergency and it's unsafe or impractical to stop. You are safely parked

Penalties for using your phone while driving - You could get 6 penalty points on your licence and a fine of £200. Your case could also go to court and you could be disqualified from driving or riding and get a maximum fine of £1,000. Drivers of buses or goods vehicles could get a maximum fine of £2,500.

Flood SUMMIT - 1st April, 2017

WCC invite you to the Warwickshire Flood Summit, taking place on Saturday 1st April in Stratford-upon-Avon. The event will start at 10am and will finish around 4:30pm. Building on the successes of the 2014 and 2015 Flood Summits, we are looking to engage with even more members of the public with the 2017 event, by making it an open public event.

The main objectives of the event are three-fold.

1. To raise awareness of flood risk and promote realistic expectations of the role of Flood Risk Management Authorities, leading to action on the part of residents and businesses, therefore leading to greater resilience.
2. To let people know that they are not alone, through displaying the positive community resilience work that has been achieved throughout the county.
3. To gathering views from the public, especially with respect to the implementation of the Warwickshire Local Flood Risk Management Strategy one year after its adoption by Cabinet in April 2016.

The event will be held in two locations within Stratford. Firstly, in the Stratford Arts House (Rother Street, Stratford, CV37 6LU) we will have stalls from various partners of ours, split into various themes (planning and development, maintenance, community resilience etc). Here, people will have the chance to speak to staff from the various agencies (EA, Severn Trent etc) and learn more about what they do to manage the flood risk in Warwickshire.

The second venue will be along Waterside, next to the RSC. Here we will have an outside public display area. On display will be a new temporary flood defense barrier from the Environment Agency along with one of their emergency response vehicles, a Warwickshire Fire and Rescue Service boat and equipment, the National Flood Forum information trailer, and some WROC instant response vehicles. As with the indoor exhibition, staff from the relevant agencies will be there to answer any questions the public may have.

At 3pm there will be a brief presentation on the theme of the Flood Summit – ‘is the Warwickshire Flood Strategy working?’ – followed by a Question & Answer session with a panel of experts from major flooding agency

This should be an extremely productive event, with a great turnout by our partners expected, and hopefully a very strong public attendance. We hope to see you there on the day.

Questions and Answers

This is a real bumper edition of the newsletter, and the theme is one of good progress, and great things to come! In each section we explain the impact on our [mapping](#), as we have changed the way in which the data is handled and this will make changes to what is represented in many areas.

Unique interactive property-level broadband checker now available

CSW Broadband has now made available a [unique interactive property-level checker](#) that enables you to find out what coverage is planned for your home or business by the end of 2019.

It's simple to use and the information returned will show one of the following classifications:

Superfast:

This means that superfast broadband may be available now, or will be by the end of 2019. This may be either through the CSW Broadband rollout or through commercial providers. **

Under Review / Alternate Provider:

This means that a supplier (not BT) has said that they will be providing superfast broadband by the end of 2019. These tend to be smaller providers. **

Basic Broadband:

There is currently no planned superfast coverage here, but the area is in scope for consideration under Contract 3, which is currently out to tender. The additional coverage will not be mapped until the procurement process is completed, probably during the autumn of 2017.

Awaiting funding:

These areas are not in scope for potential coverage under Contract 3 as we are awaiting additional funding. We continue to actively seek additional funding opportunities.

The information has been taken from the following sources:

- Open Market Review and Public Consultation that was held and the end of 2016. During this process all commercial providers were invited to submit information about their rollout plans to the end of 2019. **
- Contract 2 coverage for the CSW Broadband project.
- State Aid approved Contract 3 potential intervention area.

** Because this information is provided in commercial confidence we are not able to state which provider has said that they will go to particular areas.

Wave 5 now launched

We are delighted to announce the launch of Wave 5. As we move through the project we are seeing far fewer Fibre to the Cabinet (FTTC) upgrades. This Wave picks up mainly Exchange Only lines, with some of these being served by FTTC and many more by Fibre to the Premise (FTTP). This is great, in that it provides a superfast broadband service to homes that previously had no hope of any uplift, but it does make our job rather challenging, as we won't know until the service actually goes live which properties will benefit from the improvements.

This also means that whereas you would normally see areas on [our map](#) turning blue as each Wave is announced, only a few will show as blue until after the deployment is complete and we receive the report that identifies the successfully upgraded premises. These will then be added to the map's next update. Do check the [Rolling 12-Month Plan](#) regularly though, because where an FTTC upgrade is planned we will eventually receive a notification of the cabinet locations. Whilst we can't say exactly which properties will benefit, this may at least give some indication.

Contract 2, Part 2

The data for Contract 2, Part 2 has been received from BT. This is now shown on the [map](#) as amber, and areas will change colour as they are announced in future Waves. The total value of Contract 2, Part 2, is £2m.

Colours on top

We have made a change to the way in which areas are depicted on the map. The mapping is done by postcode, but as telecoms infrastructure does not follow postcodes this has created some difficulties. For instance, one cabinet may serve several postcodes and one postcode may be served by several cabinets. The approach we have taken in the past is to put the green (denoting that a live service is available) on top of all other colours. However, this can never present the whole picture, and it is likely that the green will mask areas where there is still work to be carried out.

For this edition of the map we have taken a different approach, and where there is further work to be carried out in a postcode area the green shading has been moved below the other colours. This gives a more representative view of what is yet to come but, as always, the caveat is that until the service goes live we will not know exactly what speeds a property may achieve.

Commercial coverage depiction on the maps

Before we go out to tender we are obliged to carry out an Open Market Review, during which all commercial providers are invited to submit (in commercial confidence) their development plans for the next three years. These areas are then mapped as black (two or more providers); grey (one provider); or cross-hatched (where one of the smaller providers has promised to cover the area, but it remains under review until coverage is confirmed).

Please bear in mind the limitations with postcode mapping as noted above, and that the map is only a representation rather than a definitive guide. Our [new interactive property-level checker](#) enables you to find out what coverage is planned for your home or business by the end of 2019.

ERDF funding bid successful

We have received confirmation that our application for ERDF funding has been successful. The money will be used primarily to extend the broadband rollout, but also for specialist ICT business support. The project runs to 2020.

The funding will be matched by our application for Local Growth Deal funding through the Coventry and Warwickshire Local Enterprise Partnership, and by all Local Authority partners. The Government has stated that they will underwrite EU funding in light of Brexit.

Both the additional broadband rollout and the business support will cover the Coventry and Warwickshire Local Enterprise Partnership area, and for the first time Coventry City Council are now able to contribute to the project so that Coventry will be included in the CSW Broadband project. More details will be released on both elements of the project as contracting progresses.

The broadband rollout will form part of the overall package for Contract 3, which is discussed below.

Contract 3 Invitation to Tender issued

Including the EU and other funding mentioned above, Contract 3 will have a total value of up to £20m. The Invitation to Tender was launched on 7th February. As discussed in the December newsletter, the area has been split into 3 lots:

Lot 1: North Warwickshire, Nuneaton & Bedworth, Rugby, Stratford District east of the M40

Lot 2: Coventry (excluding the City Centre) and Solihull to the east of the M42*

Lot 3: Warwick District and Stratford District to the west of the M40

The tenders should be returned by 2nd May, and evaluation will take 4 weeks. We therefore expect to sign contracts towards the end of June, and should be able to map the additional coverage during the autumn.

This is a full European tender, and the documentation can be found in the [Contract 3](#) section of our website.

The key difference between Contract 3 and what has gone before is that whereas superfast speeds used to be defined at 24Mbps, for Contract 3 a line must achieve 30Mbps to qualify as superfast. This is in accordance with the EU State Aid Directive.

* The area of Solihull to the west of the M42 is classified as awaiting additional funding.

Interesting statistic

Some 90% of people now believe broadband is essential, more than the 74% who think the same of a mobile phone, a television (73%) or a car (68%), while only housing, energy, food and running water are considered more important, consumers' association [Which?](#) said recently .

Questions and Answers

Here are some of the Q&A's raised recently. Our website has a full set of Q&As, which are regularly updated.

So will my property be upgraded under Contract 3?

It is too early to be able to give this level of detail. Once the Contract has been let we can start to work with the suppliers to develop a rollout strategy, and then we should be able to map the results. As there are 3 Lot areas it will be 3 x the work, so this is unlikely to be completed until late autumn.

There is no star on my property on the map, what does this mean?

Those properties without a star are anticipated to have superfast broadband by 2019. This information is derived from the Open Market Review that was carried out in 2016, during which commercial providers advised their future coverage plans. However, this information was given in commercial confidence so if commercial coverage is planned then we cannot give any further information. If your area is due to be covered as part of the CSW Broadband rollout, then the area will be coloured accordingly on the map (please refer to map key).

How do I know which BT cabinet I am connected to?

To check which cabinet you are connected to and what speeds you might achieve visit the [BT DSL checker](#). For the best results you will need to be able to enter a BT landline number for your property. If you do not have this then you can use your address, but it may be less accurate. Do not use the postcode checker as that covers too wide an area to be of any use. It should be noted that once the service is live you are not restricted to buying a service from BT and that you can go to any Internet Service Provider (ISP).
